

## **AWARD CONDITIONS - 2025 v2**

# **UniSQ Residential College Scholarship**

#### Value

The scholarship will be applied as a reduction in Residential College fees, with a maximum value of \$2300 per trimester across the 2025 academic year.

The total value will vary depending on the trimester in which the scholarship is awarded (e.g., Trimester 1, 2 or 3 2025).

## **Eligibility**

Recipient must:

- be a domestic student currently residing in Australia
- be commencing or continuing their studies at UniSQ in an undergraduate program in the trimester of application (e.g., Trimester 1 2025)
  - o continuing students must have a current Grade Point Average (GPA) of at least 4.0
- be enrolled or intending to enrol in a minimum of 2 study units per trimester (extenuating circumstances may be considered for students only studying one study unit)
- be residing or intending to reside at one of the UniSQ Residential Colleges, Toowoomba campus
- not be a resident of Steele Rudd College, Block A or B
- have their principal place of residence at least 50 kilometres from the UniSQ Toowoomba campus
- have a low-to-middle annual household income.

**Note:** There are some Centrelink payments (e.g., ABSTUDY Relocation Scholarship or ABSTUDY Residential Cost Option Scholarship) that cannot be held in the same period as the UniSQ Residential College Scholarship. We recommend you seek clarification from Centrelink before accepting a UniSQ Residential College Scholarship.

#### **Conditions**

- The scholarship is for a maximum of 1 academic year (up to 3 trimesters) and will be applied as a reduction in Residential College fees at the UniSQ Residential Colleges, Toowoomba campus.
- The scholarship does not cover the study breaks or short-term accommodation.
- If a recipient vacates UniSQ Residential Colleges part way through a trimester, the value of their scholarship will be applied on a pro-rata basis.
- The scholarship will be forfeited if the recipient:
  - o fails to continue to meet the eligibility criteria for the duration of the scholarship
  - does not enrol in a minimum of 2 study units per trimester (unless exceptional circumstances are granted)
  - o does not reside at one of the UniSO Residential Colleges
  - o defers their program of study
  - withdraws from study at UniSQ
  - o fails to maintain a Grade Point Average (GPA) of at least 4.0
  - commits serious misconduct, including but not limited to, the provision of false or misleading information.
- UniSQ reserves the right to alter the conditions of the scholarship.



# **AWARD CONDITIONS - 2025 v2**

A condition of the funding received for this scholarship requires the University to compile a report for government. To facilitate this process, a student survey will be sent to all scholarship recipients in approximately August. **As a recipient of this funding, there is an expectation that students will participate in this survey.** 

## **Payment**

- Payments are applied to the recipient's Residential College account approximately 4 weeks after the census date in each trimester (as applicable), at a rate of \$2300 per trimester.
- Payment of subsequent fee reduction/s (if applicable) will be subject to satisfactory progress in the recipient's study program. In the event the recipient does not continue to meet the scholarship's eligibility criteria and conditions, they may be required to show cause why the scholarship should not be cancelled.
